





RESOLUTION NO. 83

RESOLUTION REQUESTING THAT AN ELECTION BE HELD ON THE QUESTION
OF ANNEXING CERTAIN TERRITORIES TO THE CITY OF WHITE BEAR LAKE, MINN.

WHEREAS, a certain petition dated the 3rd day of May, 1957, requesting that an election be held on the question of annexing certain territory described therein to the City of White Bear Lake, Minnesota, was duly presented to this Council on the 9th day of May, 1957, and

WHEREAS, said petition is in proper form and it appears therefrom that the same was signed by the required number of legal voters and that the territory therein described contains 749 persons and is within one and one half miles of this City Limits; and

WHEREAS, the territory proposed to be annexed is properly to be subjected to City Government; and

WHEREAS, this Council finds that annexation would be to the best interests of the City and of the territory to be annexed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of White Bear Lake, Ramsey County, Minnesota:

That an election is hereby called and directed to be held on the 25th day of May, 1957, at the Guy Fisher Garage, 5436 E. Bald Eagle Blvd., at which election all qualified voters residing within the territory described in said petition may vote for or against the annexation of said territory to the City of White Bear Lake; and the polls at said election shall be open from 7:00 A.M. o'clock until 8:00 P.M. o'clock of said day.

1. Mrs. Henry Swanson, 2291 Buffalo Street, Mr. Oscar Blien, 5440 E. Bald Eagle Blvd. and Mrs. W. A. Moisesku, 5761 Lake Ave., all residing within said territory, are hereby appointed to be Judges of said election, and the Judges of said election shall conduct the election so far as is practicable in accordance with the laws regulating the election of City Officer.
2. That the City Clerk shall cause notice of said election to be given in the manner prescribed by law.



PETITION FOR ANNEXATION

5/6/1957

To the City Council of the City of White Bear Lake, Minnesota:

We, the undersigned, legal voters of the territory hereinafter described, hereby petition your honorable body to fix a time and place when and where the resident voters within that territory may vote on the question of annexing the same to the city, and for that purpose respectfully state:

1. All of your petitioners are qualified voters and reside within the territory hereinafter described.

2. Said territory abuts upon the city limits at a north boundary thereof, and none of it is presently a part of an incorporated city, village, or borough.

3. The territory which it is proposed to annex consists partly of lands which have been platted into lots and blocks, which plats have been duly and legally made and certified according to the laws of this state and filed in the office of the Register of Deeds of the County of Ramsey, Minnesota, and partly of unplatte lands, all of which are suitable for village government. All of said lands, platted and unplatte, lie entirely within the County of Ramsey, Minnesota, and the description of said lands, both platted and unplatte, is as follows:

all that part lying north and west of the present limits of the City of White Bear Lake bounded as follows: commencing at the center of the intersection of Hammond Road and Centerville Road; thence running northerly along the center line of Centerville Road to the center of Section 4; thence running easterly along the 1/4 section line to the east 1/4 corner thereof; thence running north along the east line of said Section 4 to the north county line (Ramsey-Anoka county line); thence running easterly along the north county line to its point of intersection with the center line of trunk highway 61; thence running southerly along the center line of trunk highway 61 to a point where it intersects with the north limits of the City of White Bear Lake; thence running westerly along the northerly limits of the City of White Bear Lake to the point of beginning.

4. The quantity of land embraced within the foregoing description, and bounded as described, is approximately 1530 acres.

5. The foregoing territory, both platted and unplatte, and bounded as described, contains a resident population of 749 persons, as ascertained by a census which was commenced on the 2 day of April, 1951, and completed on the 19 day of April, 1951, a copy of which is attached hereto and made a part hereof.
