



We, the undersigned, voters who have resided within the territory herein described for more than Two (2) years prior to the date of this petition, hereby petition the County Board of the County of Anoka, State of Minnesota, to call an election for the determination of the proposed incorporation of the territory herein described as a village.

That the boundaries of the territory to be incorporated are as follows, to-wit:

Commencing at the Northeast corner of the Township of Bethel, Anoka County, Minnesota, thence Southerly along the Easterly line of Bethel Township to the Southeast corner thereof; thence Westerly along the South line of Bethel Township to the Southwest corner thereof; thence Northerly along the Westerly line of Bethel Township to the Northwest corner of the Southwest Quarter of the Northwest Quarter of Section 31, Township 34, Range 23, County of Anoka, thence East along the township boundary and along the North line of the Southwest Quarter of the Northwest Quarter to the Southwest corner of the Northeast Quarter of the Northwest Quarter; thence North along the township boundary and along the West line of Northeast Quarter of the Northwest Quarter of Section 31, Township 34, Range 23, and along the West line of the East Half of the Southwest Quarter of Section 30 and the West line of the Southeast Quarter of the Northwest Quarter of Section 30 to the Southeast corner of the Northwest Quarter of the Northwest Quarter of Section 30, Township 34, Range 23; thence West along the township boundary and along the South line of the Northwest Quarter of the Northwest Quarter to the West line of Section 30, Bethel Township; and thence North along said West line of Bethel Township to the Northwest corner of Bethel Township; thence East along the North line of Bethel Township to the point of beginning, all being in the County of Anoka, State of Minnesota.
