ORDINANCE No. 70

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF NEW BRIGHTON TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition dated April 23, 1957, requesting annexation of the territory described below was duly presented to the council on the 7th day of May, 1957; and

WHEREAS, a public hearing was held on the proposed annexation on the 11th day of June, 1957;

The Council of the Village of New Brighton, ordains:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows:

Commencing at the Northwest corner of New Brighton Limits on County Road H, thence West along County Road H to the Anoka County line, thence South along Anoka County line to Twenty-second (22) Street Northwest, thence East along Twenty-second (22) Street Northwest, to the North and South Village limits of New Brighton, thence North along South Village Limits to the point of beginning, all in Township of Mounds View, County of Ramsey, State of Minnesota.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance in the office of the secretary of state and in the office of the county auditor of Ramsey County.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3.
