



CERTIFICATION



ORDINANCE NO. 5

AN ORDINANCE ANNEXING CERTAIN PLATTED TERRITORY TO THE VILLAGE OF SHOREVIEW PURSUANT TO THE PROVISIONS OF MINNESOTA STATUTES 1953, SECTION 412.041, SUBDIVISION 4.

THE VILLAGE COUNCIL OF THE VILLAGE OF SHOREVIEW HEREBY ORDAINS AS FOLLOWS:

Section 1. The property hereinafter described, being all platted property, concerning which a petition signed by all of the owners of all of the property contained in said description has been presented to the Council of the Village of Shoreview pursuant to Minnesota Statutes 1953, Section 412.041, Subdivision 4, and acts amendatory thereof, requesting that said property be annexed to said Village, the Council hereby determines that annexation thereof will be to the best interests of the Village and the territory affected.

Sec. 2. The Council of the Village of Shoreview hereby declares, pursuant to Minnesota Statutes 1953, Section 412.041, Subdivision 4, and acts amendatory thereof, that the following described property is hereby annexed to the Village of Shoreview and is hereby declared to be a part of said village:

All that part of Auditors Subdivision No. 32 in Section Thirteen (13), Town twenty-nine (29) North, Range twenty-three (23) West, lying Easterly of the centerline of Hodgson Road and including that portion of County Road 62 within said portion of said Subdivision No. 32, in the County of Ramsey, State of Minnesota, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said county of Ramsey.
