

ORDINANCE No. 7

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE VILLAGE OF NORTH OAKS VILLAGE TO INCLUDE  
CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition dated *May 9*, 1957, requesting  
annexation of the territory described below was duly presented to the  
Council on the 9th day of May, 1957; and

WHEREAS, a public hearing was held on the proposed annexation on  
the 13th day of June, 1957;

The Council of North Oaks Village ordains:

Section 1. Declaration. It is hereby determined that the territory  
described below abuts upon the village and is so conditioned as properly  
to be subject to village government.

Section 2. Territory Annexed. The corporate limits of the village  
are hereby extended to include the territory described as follows:

All that part of the southeast quarter of the southwest quarter  
(SE $\frac{1}{4}$ SW $\frac{1}{4}$ ) of Section 13, T.30., R.23, easterly of the centerline  
of State Trunk Highway 49 (Hodgson Road), and northerly of the  
north line of the right-of-way of State Trunk Highway 96,  
abutting upon the incorporated village of North Oaks Village,  
all in Township of Mounds View, County of Ramsey, State of Minnesota

Section 3. Filing. The village clerk is hereby directed to file  
certified copies of this ordinance in the office of the Secretary of State  
and in the office of the county auditor of Ramsey County.

Section 4. Effective Date of Annexation. Annexation shall be com-  
plete from and after the date when certified copies of this ordinance have  
been filed as directed in Section 3.
