

RECIPROCAL AGREEMENT

BETWEEN THE

STATE OF MINNESOTA AND THE STATE OF WEST VIRGINIA

The duly authorized officials of the state of Minnesota and the state of West Virginia acting by and through the authority granted to them by the law of their respective states, hereby agree to reciprocally waive payment of all motor vehicle registration or license plate fees for vehicles owned by Minnesota residents and properly and lawfully registered in Minnesota when operating into or through the state of West Virginia; and to reciprocally waive payment of such fees for such vehicles owned by West Virginia residents and properly and lawfully registered in West Virginia when operating into or through Minnesota under and subject to the following conditions and limitations:

I

Private passenger automobiles and trailers or house trailers attached thereto are entitled to full reciprocity for a period of ninety (90) days provided the owner does not engage in a gainful occupation while temporarily residing in the reciprocating state.

II

Reciprocity privileges shall not extend to commercial vehicles such as trucks, buses, truck-tractors, trailers and semi-trailers while being operated in intrastate commerce.

III

Nothing contained in this agreement shall be construed to waive compliance with the weight, length, width or traffic laws of the respective states.

IV

Nothing contained in this agreement shall be construed to apply to regulatory laws, rules or regulations of the respective states as administered by the West Virginia Public Service Commission and the Minnesota Railroad and Warehouse Commission.

This agreement shall become effective immediately after it has been approved by the authorized officials of the respective states and may be terminated by either state by giving thirty (30) days written notice.
