ORDINANCE NO. 108

An Ordinance Annexing Part of Lot 1 of Town of East Shore to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI TO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of the Easterly Half of Lot 1, Town of East Shore, as hereinafter more particularly described, in Washington County, Minnesota, containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at a point in the center line of Maple Street 314.44 feet West of the center line of Hallam Street, thence North at right angles to said center line of Maple Street through Lot One (1) of Town of East Shore to the Southerly right-of-way line of the Northern Pacific Railway; thence Easterly along said right-of-way line to the center line of Hallam Street; thence South along the center line of Hallam Street to the center line of said Maple Street; thence West along the center line of Maple Street to the point of beginning,

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and from and after its publication.
