ORDINANCE NO. 78

AN ORDINANCE EXTENDING THE VILLAGE BOUNDARIES

THE VILLAGE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, DO ORDAIN
AS FOLLOWS:

Section 1. That the Village boundaries of the Village of Foley are hereby extended so as to include the following described parcels of land abutting upon said village, to-wit:

(a.) The following described parcels of land in the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29)

(1.) The North 120 feet of the West 150 feet of the East 183 feet of said forty acre tract, now of record in the names of Norman E. Fidelman and Marion Fidelman, husband and wife.

(2.) The South 90 feet of the North 210 feet of the West 150 feet of the East 183 feet of said forty acre tract, now of record in the names of Bernard F. Deppa and Kathryn P. Deppa, husband and wife.

(3.) The South 90 feet of the North 300 feet of the West 150 feet of the East 183 feet of said forty acre tract, now of record in the names of Benedict P. Latterell and Kathleen M. Latterell, husband and wife.

(4.) A tract 150 feet by 112.9 feet in said forty acre tract, described as follows:

Beginning at a point 2,230.6 feet north and 33 feet west of the south quarter corner of said Section Twenty-six (26); Thence north along the west line of a public road 112.9 feet; Thence west and at right angles to the west line of said road 150 feet; Thence south and parallel to said road 112.9 feet; Thence east 150 feet to the point of beginning; now of record in the name of Floyd J. Elwell.

(b.) Lot numbered Two (2) of Auditor's Subdivision of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of said Section Twenty-six (26), now of record in the name of Frances Nesselth, formerly Frances Nordenstrom.
