# EXECUTIVE ORDER 1957 No. /3

WHEREAS Laws 1957, Chapter 650,

"An Act relating to employees of certain political subdivisions who hold positions covered by teachers retirement fund associations established in certain cities and providing for their coverage under the old age and survivors insurance provisions of Title II of the Federal Social Security Act as amended",

## provides in part as follows;

"Sec. 2. Pursuant to section 218(d)(6) of the Social Security Act, every teachers retirement fund association established under the provisions of Minnesota Statutes 1953, sections 135.19 to 135.27, as amended, shall be deemed to constitute a separate retirement system."

"Sec. 3. Subdivision 1. Upon the request of the governing body of any teachers retirement fund association and the board of education or upon the petition of at least ten percent of the active members of any such association and the board of education in a city of the first class situated in counties having an area of over 5,000 square miles, the governor shall be empowered to authorize a referendum to be held at a date to be set by him, and to designate any agency or individual to supervise its conduct, in accordance with the requirements of section 218(d) (3) of the Social Security Act, on the question of whether service by teachers in positions covered by such teachers retirement fund association should be excluded from or included in an agreement under the enabling act. \* \* \*"

AND WHEREAS the Duluth Teachers Retirement Fund Association is within the purview of Laws 1957, Chapter 650, and

WHEREAS the governing body of the Duluth Teachers Retirement Fund Association and the Board of Education of the City of Duluth have duly requested the Governor to authorize a referendum pursuant to the aforesaid statutes and in accordance with Sec. 218(d) (3) of the Federal Social Security Act,

I, THEREFORE, AS GOVERNOR OF THE STATE OF MINNESOTA, order and direct that there shall be conducted on November 14, 1957, a referendum with respect to the teachers of said Association as in Laws 1957, Chapter 650 provided, and that in such referendum there shall be submitted the question of whether service by teachers in positions covered by such Teachers Retirement Fund Association should be excluded from or included in an agreement under the enabling act, Laws 1955, Chapter 665, and Sec. 218 of the Federal Social Security Act, as amended.

I hereby designate the Clerk of the Board of Education of the City of Duluth as the agency to conduct the referendum pursuant to Laws 1957, Chapter 650, to give notice of, to conduct, and to supervise the said referendum, which said notice of referendum required by Sec. 218(d) (3) (C) of the Social Security Act to be given to teachers shall contain or shall be accompanied by a statement in such form and detail as said agency shall deem necessary and sufficient to inform the teachers of the rights which will accrue to them and their dependents and survivors, and the liabilities to which they will be subject, if their services are included in an agreement under Laws 1955, Chapter 665, and the statement shall contain such form and such detail as he shall deem necessary, the plan proposed for the integration, supplementation or combination of the Teachers Retirement Fund Association and social security. The cost of such referendum shall be paid by the Duluth Teachers Retirement Fund Association.

I further direct that upon completion of such referendum the agency herein designated shall certify to me the results thereof, which said certification shall also include a statement of the number of those eligible to vote, the number of those who voted for inclusion, the number of those who voted for exclusion, a copy of the notice of referendum, a copy of the ballot used in such referendum, a copy of all instructions and advice given by the agency relative to such referendum; and such agency shall certify to me in such certification, if it be the fact, that said referendum was conducted in full compliance with all the conditions and requirements of Laws 1957, Ghapter

650, and of Sec. 218(d) of the Federal Social Security Act as amended.
