Whereas, Chapier 613, Laws of Minnesota for 1957, authorizes the governing body of the City of Saint Paul, not less than sixty days after April 25, 1957, to adopt a resolution by majority vote of the members of said government body, fixing and establishing the primary election of city officials in said city on the second or third Tuesday in March every two years so that the primary will be on the same day as the presidential preference primary; therefore, be it.
