Council File No. 184022—By Bernard T. Holland—
 Whereas, Chapter 613, Laws of Minnesota for 1957, authorizes the governing body of the City of Saint Paul, not less than sixty days after April 25, 1957, to adopt a resolution by majority vote of the members of said government body, fixing and establishing the primary election of city officials in said city on the second or third Tuesday in March every two years so that the primary will be on the same day as the presidential preference primary, therefore, be it
 Resolved, That the Council of the City of Saint Paul hereby fixes and establishes the second Tuesday in March of each even-numbered year for the holding of the primary municipal election; be it
 Further Resolved, That the City Clerk shall forthwith file a duly certified copy of this resolution with the Secretary of State of Minnesota, and a certified copy of this resolution with the Register of Deeds of Ramsey County.
