

The following ordinance was presented to the Council of the Village of Kasson, at a regular session, September 3, 1957. Councilman Laudon moved that it be adopted. The motion to adopt the ordinance was seconded by Blaisdell, whereupon it was put to a vote. The following members voted "yes", Peterson, Hanson, Tietje, Blaisdell and Laudon. None voted against, whereupon the ordinance was declared approved and adopted.

ORDINANCE NO. 415

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE OF THE VILLAGE OF KASSON, DINNESOTA, KNOW AS ORDINANCE NO. 414 AND ENTITLED AS FOLLOWS: "AN ORDINANCE EXTENDING THE COMPORATE LIMITS OF THE VILLAGE OF KASSON".

The Village Council of Kasson, Minnesota ordains:

MARRIAS the property description contained in Ordinance No. 414 was incorrectly stated:

NOW THEREFORE, That certain Ordinance of said Village of Kasson, Minnesota, known as Ordinance No. 414 bearing date of July 2, 1957 and entitled as follows:

"An Ordinance extending the corporate limits of the Village of Kasson", shall be and the same so hereby amended so as to read as follows:

SECTION I. The corporate limits of the Village of Kasson are hereby extended to include the following described territories situated in the County of Dodge, State of Hinnesota:

Commencing at a point Fifty-nine (59) feet West of the Southeast corner of the Northwest quarter of Section 28, Township 107 North, Renge 16 West; Thence North along the right-of-way of Highway # 57 a distance of 1764.33 feet; thence West One Hundred Highty (180) feet; thence South 1764.33 feet; thence East One Hundred Highty (180) feet to the point of beginning.

SECTION II. That the Village Clerk is hereby directed to file a copy of ordinance in the office of the Secretary of State and in the office of the Auditor of Dodge County, Minnesota.

SECTION III. This ordinance shall take effect and be in full force from and after its passage and publication as provided by law.
