ORDINANCE NUMBER 17.

An Ordinance extending the village boundaries to include certain unplatted land :

The village council of the village of Pequot, in the county of Crow Wing, state of Minnesota, do ordain as follows:

Section 1. That the following described ^{unplatted} land, viz:- The south twenty eight (28) rods, of the southwest quarter ($\frac{1}{4}$) of the southwest quarter ($\frac{1}{4}$), of section number eleven (11), in township number one hundred thirty six (136) North of range twenty nine (29), in the county of Crow Wing, and state of Minnesota, (Excepting those tracts or parcels deeded to Nels Ellingson, Nels Anderson, and The Evangelical Lutheran Christ Association), and containing ten acres and a fraction. Also, commencing at a point three hundred and thirty three (333) feet north of the southwest corner of the west half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$), of section number eleven (11), in township number one hundred thirty six (136), North of range twenty nine (29), said county and state. Thence, north seventy six (76) feet, thence east one hundred (100) feet, thence south seventy six (76) feet, and thence west one hundred (100) feet to the point of beginning, containing twenty five one hundredths (25-100) of an acre. Also, commencing twenty eight (28) rods north of the southwest corner of the west half ($\frac{1}{2}$) of the southwest quarter ($\frac{1}{4}$) of section number eleven (11), in township number one hundred thirty six (136), north of range twenty nine (29), said county and state. Thence east eighty (80) rods, thence north twenty (20) rods, thence west eighty (80) rods and thence south twenty (20) rods to the place of beginning, containing ten (10) acres, abutting upon the incorporated village of Pequot, in the county of Crow Wing, and state of Minnesota, and not exceeding twenty one (21) acres, be and the same are hereby included within the corporate limits of said village of Pequot, and the village boundaries extended so as to include the same, and become a part of said village as effectually as if it had been originally a part thereof.

Section 2. This ordinance shall ~~take~~ take effect and be in force on and after its publication.

Ordinance Number 17.

An Ordinance extending the village boundaries to include certain unplatted land:

The village council of the village of Pequot, in the county of Crow Wing, state of Minnesota, do ordain as follows:

Section 1. That the following described unplatted land, viz: The south twenty eight (28) rods of the southwest quarter [S.W. 1/4] of the southwest quarter [S.W. 1/4], of section number eleven [11], in township number one hundred

thirty six [136] North of range nine [29], in the county of Crow Wing, and state of Minnesota, [excepting those tracts or parcels deeded to Nels Ellingson, Nels Anderson, and The Evangelical Lutheran Christ Association], and containing ten acres and a fraction. Also, Commencing at a point three hundred and thirty three [333] feet north of the southwest corner of the west half [W. 1/2] of the southwest quarter [S.W. 1/4], of section number eleven [11], in township number one hundred thirty six [136], north of range twenty nine [29], said county and state, Thence north seventy

six [76] feet, thence east one hundred [100] feet, thence south seventy six [76] feet, and thence west one hundred [100] feet to the point of beginning, containing twenty five one hundredths (25-100) of an acre. Also, Commencing twenty eight (28) rods north of the southwest corner of the west half [W. 1/2] of the southwest quarter [S.W. 1/4] of section number eleven [11], in township number one hundred thirty six [136], north of range twenty nine [29], said county and state, Thence east eighty [80] rods, thence north twenty [20] rods, thence west eighty [80] rods and thence south twenty

20 rods to the place of beginning, containing ten [10] acres, abutting upon the incorporated village of Pequot, in the county of Crow Wing, and state of Minnesota, and not exceeding twenty one [21] acres, be and the same are hereby included within the corporate limits of said village of Pequot, and the village boundaries extended so as to include the same, and become a part of said village as effectually as if it had been originally a part thereof.

Section 2. This ordinance shall take effect and be in force on and after its publication.
