ORDINANCE NUMBER ELEVEN

AN ORDINANCE CHANGING THE NAME OF NORTH OAKS VILLAGE TO NORTH OAKS.

WHEREAS the Village Council of North Oaks Village did, on October 10, 1957, receive a petition signed by 20% of the legal voters resident in North Oaks Village requesting that the question of changing the name of North Oaks Village to North Oaks be put on the ballot at the next ensuing village election, and

WHEREAS, at the Village Election on November 5, 1957, a majority of all votes cast upon the question were in favor of such change,

NOW, THEREFORE, The Village Council of North Oaks Village does ordain as follows:

SECTION 1. The name of the village of North Oaks Village shall be changed to North Oaks. SECTION 2. This ordinance shall take force and be in effect from and after its passage and publication.
