ORDINANCE NO. 110

An Ordinance Annexing the West 200 feet of Lot Two (2) and all of Lot Three (3) of Hanson's Addition to Town of East Shore, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI TO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of the West 200 feet of Lot Two (2) and all of Lot Three (3) of Hanson's Addition to Town of East Shore, as hereinafter more particularly described, in Washington County, Minnesota, containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at the intersection of the center lines Woodland Street and Warner Avenue, thence North along the center line of Warner Avenue to the intersection with the center line of Hanson Street; thence East along the center line of Hanson Street to a point 200 feet East of the West line of Lot Two (2) of said Hanson's Addition to Town of East Shore; thence South parallel to the West line of said Lot Two (2) to the center line of the twenty foot public lane or alley running between said Lots Two (2) and Three (3); thence East along the center line of said public lane to the center line of Griffin Street; thence Southeasterly along the center line of Griffin Street to the center line of Woodland Street; thence West along the center line of Woodland Street to the point of beginning,

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as of the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and Secretary of State of the State of Minnesota and from and after its publication.
