ORDINANCE # 27

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CHANHASSEN,  
TO INCLUDE CERTAIN PLATTED AND UN-  
PLATTED/TOT EXCEEDING 200 ACRES IN  
AREA

WHEREAS, A certain petition dated January 9, 1958, requesting annexation of the territory described below was duly presented to the Council on the 9th day of January, 1958, and,

WHEREAS, A public hearing was held on the proposed annexation on the 14th day of February, 1958;

The Council of the Village of Chanhassen ordains;

Section 1. - Declaration. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to Village Government;

Section 2. - Territory Annexed. The corporate limits of the Village are hereby extended to include the territory described as follows:

Commencing at the Southeast corner of the Southwest Quarter of Section 12, Township 116 North of Range 23 West; thence North on the East line of said Southwest Quarter 245 feet to the point of beginning of the land to be herein described; thence angle left  $74^{\circ}31'40''$ , 660.22 feet; thence angle left  $13^{\circ}47'10''$  a distance of 16.5 feet to the West line of the East half of the Southeast Quarter of the Southwest Quarter; thence North on said West line to the North line of Southeast Quarter of Southwest Quarter, Section 12; thence East along the North line of the Southeast Quarter of Southwest Quarter and the Southwest Quarter of Southeast Quarter said Section 12, to the Northeast corner of the Southwest Quarter of the Southeast Quarter of said Section 12; thence South along the East line of said Southwest Quarter of Southeast Quarter, a distance of 572.7 feet to the North line of St. Aloys Street, Chanhassen Village, Carver County, Minnesota; thence running West along the North line of St. Aloys Street, a distance of 1336.9 feet to the West line of the Southwest Quarter of the Southeast Quarter of Section 12 Township 116 Range 23; thence South along the West line of the said Southwest Quarter of Southeast Quarter to the point of beginning.

Section 3. - Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State and in the office of the County Auditor of Carver County, Minnesota.

Section 4. - Effective date of annexation. Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3.
