

I, JOSEPH L. DONOVAN, Secretary of State of the State of Minnesota, and keeper of the Great Seal of said State, do hereby certify:

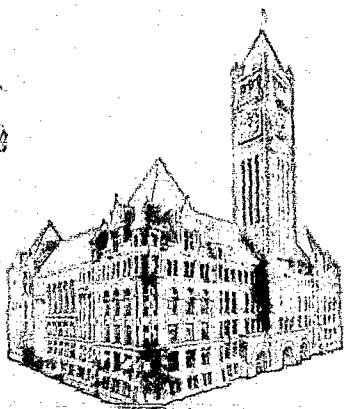

That on the 21st day of March, 1948 at 4:00 p.m., there was filed in the office of the Secretary of State an Amended Census List relative to the Incorporation of the Village of Greenfield, which declares the population of the Village of Greenfield, Hennepin County, Minnesota, to be Six Hundred and Nineteen (619), all contained in our Official Document File No. 13695.

Enclosed herewith is a copy of the amended census list in the matter of the incorporation of the Village of Greenfield, the original of which list was filed in this office this morning, March 19th. It should be attached to the Greenfield incorporation file which we mailed to you on March 12th.

This list corrects an error in Item No. 34 of the original census list which omitted the number of residents living in the Greenwood Salem Lutheran School and Minister's home. These four residents account for the difference between 619 residents as claimed and the 615 residents as tabulated.

Commissioner Matthews offered the following resolution and moved its adoption:

BE IT FURTHER RESOLVED, That the County Auditor cause notice of said election to be given in the manner prescribed by law.
