An Ordinance Annexing Land in Block 3 of East Shore Heights and in Lot 2 of "Hanson's Addition to Town of East Shore" To the Villago of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MANTO MET TO GETWIN AS MOLLOWS:

Section 1. That pursuant to that cortain potition alone by the anjority of the owners of Lots Fifteen (15) through Twenty-three (23), both numbers inclusive, in Block Three (3) of East Chore Heights, and all of Lot Two (2) except the West Two Hundred (200) feet thereof, in Hanson's Addition to Town of East Shore, in Hashington County, Mannesota, adjoining the Village of Mahtomedi and containing less than 200 acres, requesting the annexation of said land to said village, said petition having been filed with the Club of said Village on February 4, 1958, and after a public hearing on said petition held on April 1, 1958 after thirty days posted notice of said hearing as required by law, and it appearing that such annexation will be to the bests interests of said Village and the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at the intersection of the center lines of the two ten-foot lanes running through Block Three (3) of East Shore Heights, thence East along the center line of the East-West ten-foot lane to the center line of Griffin Street; thence Southerly along the center line of Griffin Street to the center line of the East-West twenty-foot lane running between Lots Two (2) and Three (3) of Hanson's Addition to Town of East Shore; thence Vest along the center line of said twenty-foot lane to a point Two Hundred (200) feet East of the lest line of said Lot Two (2); thence North on a line parallel to the West line of said Lot Two (2) to the center line of Hanson Street; thence West along the center line of Hanson Street to the intersection with the center line of the North-South ton-foot lane in said Block Three of East Shore Heights; thence North along the center line of said North-South tenfoot lane to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as of the same had originally been a part of said Village. Section 2. This Ordinance shall take effect and be in force usen the filing of a certified copy thereof with the County Auditor of dashington County and Secretary of State of the State of Minnesota and from and after its publication.
