

AN ORDINANCE

ANNEXING THE FOLLOWING DESCRIBED REAL ESTATE,

TO - WIT:

A part of the South Half ($S\frac{1}{2}$) of the Southwest Quarter ($SW\frac{1}{4}$) of Section Twenty (20), Township One Hundred Seven (107), North of Range Seven (7), West of the Fifth Principal Meridian, described as follows: Commencing at a point in the center of the public highway known as Gilmore Avenue, one (1) rod West of the South Quarter post of Section Twenty (20); thence at right angles due North thirty two (32) rods; thence at right angles due West five (5) rods; thence at right angles due South thirty two (32) rods to the center of said road; thence along the center of said road due East five (5) rods to the place of beginning, containing one (1) acre more or less in the County of Winona and State of Minnesota.

Section 1.
