

WHEREAS, Through a clerical error, the said census did not set forth a correct figure for the total population of the territory described in the foregoing petition and,

WHEREAS, Based upon the census as originally prepared and filed, the undersigned prepared and signed their petition above mentioned, stating the resident population of the area to be 5738 persons.

NOW THEREFORE, The undersigned, for the purposes of remedying a clerical error in the preparation of the "Petition for Incorporation of The Village of Mounds View" dated March 17, 1958, and conforming the said petition to the facts, do hereby amend paragraph 7 of the said petition to read as follows:

"A census of the resident population of the said area was currently taken commencing March 6, 1958 and ending March 16, 1958 and the number of actual residents is 5726. Attached hereto and marked Exhibit "A" and made a part hereof is a list prepared from the data submitted by the persons who took the census and said list shows the location of all residential buildings in the areas by the street address and the number of persons resident in each such building."





WHEREAS A petition was on March 17, 1958, filed with the County Auditor of Ramsey County, Minnesota, requesting that certain land situate in the Town of Mounds View, County of Ramsey and State of Minnesota, described as follows, to-wit:

Section five (5), except therefrom the North $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ which is included in the Village of Blaine,

Section six (6), except therefrom lots fourteen (14) through nineteen (19) and lots twenty seven (27), twenty eight (28) and twenty nine (29) of Auditor's Subdivision No. 89 which are included in the Village of Spring Lake Park,

All of Sections seven (7) and eight (8),





The undersigned hereby propose the incorporation as a village the following territory, situated in the Township of Mounds View, County of Ramsey, State of Minnesota, described as follows:

The following in Township 30 North, Range 23 West described as follows:

Section five (5), except therefrom the North $\frac{1}{2}$ of the North-east $\frac{1}{4}$ which is included in the Village of Blaine.

Section six (6), except therefrom lots fourteen (14) through nineteen (19) and lots twenty seven (27), twenty eight (28) and twenty nine (29) of Auditor's Subdivision No. 89 which are included in the Village of Spring Lake Park.

All of Sections seven (7) and eight (8).

Also, the Northeast $\frac{1}{4}$ of Section seventeen (17).

The undersigned further represent as follows:

They are voters who have resided continuously in the above described area for at least two years, immediately prior to the date of this petition.

The area described contains 2560 acres, more or less. Of this 1349 acres is contained in platted property and no acres is divided by means of Registered Land Surveys each of which contains from --- to --- lots and is in all material respects the equivalent of a plat.

The area which is neither platted nor subject to Registered Land Surveys is adjacent to the said plat and Registered Land Surveys.

The total assessed valuation of the property which is platted or subject to Registered Land Survey is approximately \$1,404,937.00 and the assessed valuation of the property which is neither platted or subject to Registered Land Survey is approximately \$120,371.00. The total assessed valuation of the described land is \$1,525,308.00.

The areas which are platted and covered by Registered Land Surveys are used for residential purposes. Much of the unplatted area is used for residential purposes. The portion of the area not now devoted to residential use is expected to be divided and used for residential, business and industrial purposes in the future.
