

ORDINANCE NO. 5

ORDINANCE ANNEXING THE NW 1/4 OF THE NW 1/4 OF SEC. 6 OF TWP. 123 RANG. 35
TO THE VILLAGE OF BROOKTON, MINNESOTA

The Village Council of Brookton, Minnesota, ordains:

SECTION 1 -

That the Petition filed in the office of the Village Clerk on March 28, 1958, for the annexation to the Village of Brookton, of the Northwest quarter of the Northwest quarter (NW 1/4 NW 1/4) of Section 6 of Township 123 of Range 35 in Stearns County, Minnesota, in accordance with Subd. 4 of Section 412.041 of M. S. A., is in the form required by law and is signed by more than a majority of the owners of land in the said area; and that due Notice of Hearing by the Village Council on said Petition to be held April 28, 1958, at 7:30 o'clock p.m., has been given and the said Hearing has been held and all parties desiring to be heard thereon have been heard by the Council; and all in accordance with the procedures required by law; and that the said Notice and the giving thereof and all proceedings heretofore had in the said matter, are hereby ratified, approved and adopted.

SECTION 2 -

That the annexation of the above described land to the said Village will be to the best interests of the said Village and of the said land.


SECTION 3 -




