ORDINANCE NO. 17A

ORDINANCE ANNEXING CERTAIN LANDS  
TO THE VILLAGE OF MONTEREY, MAR-  
TIN COUNTY, MINNESOTA.

THE VILLAGE COUNCIL OF MONTEREY, MARTIN COUNTY, MINNESOTA, ORDAINS:

That the following described lands situate in Martin County, Minnesota, which abut the Village of Monterey, Minnesota, and are either platted or contain less than 200 acres in area and are a proper subject for Village Government, are hereby annexed to and made a part of the said Village of Monterey, Martin County, Minnesota, pursuant to a Petition filed by Alfred E. Peterson and Ruth E. Peterson and Independent School District No. 457, Minnesota, by and through its duly elected and qualified President and Clerk, said lands being described as follows, to-wit:

A part of the southeast quarter of Section Thirty One (31), Township One Hundred Four (104) North, Range Thirty Two (32) West of the Fifth Principal Meridian, bounded and described as follows: Beginning at a point 20 feet North and 38.55 feet East of the Northeast corner of Block Eight (8), Village of Monterey; thence West 1209.65 feet parallel to the North line of said Block Eight (8), to an iron stake on the East line of Minneapolis and St. Louis Railway; thence North 10°53'20" East 698.03 feet on said East right-of-way line; thence West 50.98 feet on said right-of-way line; thence North 10°53'20" East 390.15 feet on said East right-of-way line; thence East 1046.37 feet to the East line of said Section Thirty One (31), passing over an iron stake on the West right-of-way line of Minnesota Trunk Highway No. 4, 961.4 feet from the beginning of the course; thence Southerly on the East line of said Section Thirty One (31), 1114.8 feet to the point of beginning, subject to Highway Easements.
