ORDINANCE # 44

An Ordinance Extending the Corporate Limits of the Village of Young America, to include certain unplatted land not exceeding 200 acres in area.

WHEREAS, a certain petition dated ~~January~~ <sup>April</sup> 1 1958, requesting annexation of the territory described below, was duly presented to the Council on the 1ST day of ~~January~~ <sup>April</sup>, 1958, and,

WHEREAS, The petition for said annexation was signed by the sole owners of the lands involved, so that a public hearing on the proposed annexation was not necessary;

The Council of the Village of Young America ordains:

Section I. Declaration.

It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section II. Territory Annexed.

The corporate limits of the Village are hereby extended to include the territory described as follows:

All that part of the following described tract of land lying Easterly of the center line of State Highway #5 and 25, as the same is presently constructed and exists over and through said tract, viz:

Commencing at a point 432 feet South of the Southeast corner of the Northeast Quarter of the Southwest Quarter of Section 11 Township 115 Range 26; thence East 640 feet to a point in the center of the Young America and Norwood road; thence South 37<sup>34</sup> West 270 feet along the center of said road; thence West 500 feet to a point in the Quarter Section line, thence North 229 feet to place of beginning, containing 3 acres of land, excepting therefrom 1/4 acre deeded to Carl Barlan by deed recorded in Book 22 of Deeds, page 161, Register of Deeds office, Carver County, Minnesota.

Being situated in the Southwest Quarter of the Southeast Quarter of Section 11 Township 115 Range 26, and containing .43 acre, more or less.

Section III. Filing.

The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State, and in the office of the County Auditor and Register of Deeds of Carver County, Minnesota.

Section IV. Effective Date of Annexation.

Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section II.
