

ORDINANCE NO. 2-58

AN ORDINANCE ANNEXING PROPERTY TO THE VILLAGE OF PRIOR
LAKE, MINNESOTA

WHEREAS, Earl Cates and Catherine E. Cates, his wife;
Joseph J. Stepka and Anna L. Stepka, his wife; Eugene Simpkins
and Catherine A. Simpkins, his wife, the owners of the following
described property to-wit:

Lots three (3), four (4), five (5), six (6),
seven (7), eight (8), nine (9), Block One (1),
Lakeside Gardens, Scott County, Minnesota,
according to the plat thereof on file and of said
record in the office of the Register of Deeds in
and for said County and State,

have petitioned the Village Council of the Village of Prior Lake,
Minnesota, to have the above described land which lies outside the
Village of Prior Lake, Minnesota, annexed to the Village of Prior
Lake, Minnesota; and

WHEREAS, the Village Council deems it advisable and in the
public interest that said property be so annexed,

NOW THEREFORE, the Village Council of the Village of Prior
Lake, Minnesota, does ordain as follows:

SECTION 1.

That the following described property to-wit:

Lots three (3), four (4), five (5), six (6),
seven (7), eight (8), nine (9), Block One (1),
Lakeside Gardens, Scott County, Minnesota,
according to the plat thereof on file and of said
record in the office of the Register of Deeds in
and for said County and State,

which lies outside the corporate limits of the Village of Prior
Lake, Minnesota, be and the same is hereby annexed to the Village
of Prior Lake, Minnesota, and said property is hereby declared to
be an addition to said Village.

Upon the execution date of this Ordinance such property shall become a part of said Village as effectively as if it had been originally a part thereof.

SECTION 2.

This Ordinance shall take effect and be in force from and after its passage and publication and the Village Clerk is hereby directed to cause certified copies of this Ordinance to be recorded and filed in the Office of the Register of Deeds of Scott County, Minnesota, and in the Office of the Secretary of State of the State of Minnesota.
