## ORDINANCE NO. 106.

## AN ORDINANCE RELATING TO THE ANNEXATION OF LANDS

The Village Council of the Village of Olivia, Minnesota, ordains:

1. The land described as a strip of land 150 ft. wide running in an easterly and westerly direction corresponding to, and being identical to, the strip presently held by the State of Minnesota as an easement for Highway No. 212 beginning at the intersection of said strip with the West Boundary Line of the Corporate Limits of the Village of Olivia, Minnesota, (at the Southwest Corner of Lot #10, Sunset Acres, Olivia, Minnesota), and thence running Westerly and terminating at the intersection of said strip with the West Boundary Line of the Southwest Quarter of the Southeast Cuarter of Section 12, Township 115, North of Range 25, West, Renville County, Minnesota, the whole of said strip being in the Southwest Quarter of the Southeast Quarter of Section 12, Township 115, North of Range 25, West of the 5th.
