ORDINANCE NO. 117

An Ordinance Annexing Lots Four (4) and Five (5) in Block One (1) of East Shore Heights, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of Lots Four (4) and Five (5) in Block One (1) of East Shore Heights, as hereinafter more particularly described in Washington County, Minnesota, containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

Commencing at the intersection of the center lines of Juniper Street and Griffin Avenue; thence East along the center line of Juniper Street to the intersection with the East line of Lot Four (4) in Block One (1) of East Shore Heights, extended Northerly to said center line; thence South and along the East line of said Lot Four (4) to a point 7.5 feet South of the Southeast corner of said Lot Four (4), being on the center line of a 15 feet public lane or alley adjoining the South lines of Lots Four (4) and Five (5) in Block One (1) of East Shore Heights; thence West along the center line of said lane to the center line of Griffin Avenue; thence North along the center line of Griffin Avenue to the point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as of the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and Secretary of State of the State of Minnesota and from and after its publication.
