





ORDINANCE NO. 1.7004

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MADOLIA, MINNESOTA, TO INCLUDE CERTAIN PLATTED LAND

THE VILLAGE COUNCIL OF THE VILLAGE OF MADOLIA, MINNESOTA, ORDAINS:

Section 1. DECLARATION.

Petitions having been filed herein requesting the annexation of the territory described below which petitions were duly presented to the Council on August 25, 1958, it is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. TERRITORY ANNEXED.

The corporate limits of the Village of Madolia, Minnesota, are hereby extended to include the territory described as follows:

A. The last 70 feet of the north 90 feet of Lot 1 of Driggers subdivision of the west one-half of the northwest quarter of Section 26, Township 107, Range 30.

B. Lots 11 and 12 of Block 2 of Turnsworth's Addition to the Village of Madolia, Minnesota.

C. Lots 8, 9, 10, 13 and 14 and the south 65 feet of Lot 7, Block 2, of Turnsworth's Addition to the Village of Madolia, Minnesota.

D. Beginning at the southwest corner of Lot 10 of Driggers subdivision of Lot 6 of the west one-half of the northwest quarter of Section 26, Township 107, Range 30, thence south 95 feet, thence east 200 feet, thence north 95 feet, thence west 200 feet to the point of beginning.

E. The north 60 feet of the south 141 feet of Lot 10 of Driggers subdivision of Lot 6 of the west one-half of the northwest quarter of Section 26, Township 107, Range 30.

Section 3. FILING.

The village clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State and in the office of the County Auditor of Watonwan County, Minnesota.

Section 4. EFFECTIVE DATE OF ANNEXATION.

Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3.
