

ORDINANCE NO. 167

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN.

The City Council, City of Staples, do ordain as follows:

Section 1. Pursuant to a Petition duly signed by a majority of the owners of the property described herein, and pursuant to a Resolution adopted by the unanimous consent of the City Council, following a hearing duly held upon the petition for annexation, the following described property, which is suitable for municipal government, and which property abuts upon and is adjacent to the City limits of the City of Staples, Todd County, Minnesota, and which property is described as follows, to-wit:

Commencing at the northeast corner of Lot Six (6) of Block One (1), Sharkey & Grant First Addition to Staples, thence east 328 feet to the northwest corner of Lot Seven (7) of Block Two (2), Sharkey & Grant Addition to Staples; thence south a distance 300 feet to the southwest corner of Lot Twelve (12) of Block Two (2), Sharkey & Grant Addition to Staples, thence West a distance of 328 feet to the southeast corner of Lot One of Block One (1), Sharkey & Grant Addition to Staples; thence north a distance of 300 feet to the place of beginning, including all abutting streets and alleys;

Also described as the East one-half of Block One, Sharkey and Grant Addition to Staples and the West one-half of Block Two, Sharkey & Grant Addition to City of Staples, including all streets and alleys platted therein.

The corporate limits of the City of Staples are hereby extended to include the above described lands within its said limits, and the above described lands shall hereafter be included within the corporate limits of said City of Staples and shall be a part of said City of Staples and shall be governed as other lands and territory in said City of Staples and the existing limits of the said City of Staples shall be changed so as to include the above described lands and areas.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication.
