AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF  
THE CITY OF STAPLES AND INCORPORATING ADDITIONAL  
TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. Pursuant to a petition duly signed by all of the owners of the following described property, and which property is suitable for municipal government, and which property abuts upon and is adjacent to the City of Staples, Todd County, Minnesota, and which property is described as follows, to-wit:

Commencing at the Northwest Corner of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section One (1), Township One Hundred Thirty-three (133) North, Range Thirty-three (33) West, thence running South on the West line of said NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section One (1), 330 feet, and with this latter point as a point of beginning, thence running South along the said West line 189 feet, thence running East and parallel with the South line of said NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section One (1) 117 feet, thence running North and parallel with the West line of said NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section One (1) for a distance of 189 feet, thence running West 117 feet to the point of beginning, being part of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section One (1), Township One Hundred Thirty-three (133) North, of Range Thirty-three (33) West of the Fifth Principal Meridian.

And also commencing at the Northwest Corner of the Northwest Quarter of Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section One (1), Township One Hundred and Thirty-three (133) North, Range Thirty-three (33) West, thence running south 20 rods, thence east 117 feet, and with this latter point as the point of beginning, thence running east 33 feet, thence south 189 feet, thence west 33 feet, thence north 189 feet to the point of beginning,

the corporate limits of the City of Staples shall be changed so as to include the above described lands within its said limits, and the above described lands shall hereafter be included within the corporate limits of said City of Staples and shall be a part of said City of Staples and shall be governed as other lands and territory in said City of Staples are now governed.

Section 2. The City Clerk of the City of Staples is hereby directed to forward a certified copy of this ordinance to the Register of Deeds of Todd County, Minnesota, and to the Secretary of State of the State of Minnesota.

Section 3. The aforesaid lands and territory shall be annexed to the City of Staples, and this ordinance shall take effect and be in full force and effect from and after its passage, approval, and publication.

The above ordinance was passed at a regular meeting of the City Council of the City of Staples on this 26th day of August, 1958.
