

ORDINANCE NO. 5-58

AN ORDINANCE ANNEXING PROPERTY TO THE VILLAGE OF PRIOR  
LAKE, MINNESOTA

WHEREAS, Joseph J. Stepka and Anna L. Stepka, his wife;  
Donald W. Borchardt and Verna M. Borchardt, his wife, the owners of  
the following described property to-wit:

All of Block One Jo-Anna Stepka's Hi-View  
2nd Addition to Prior Lake, and

All that part of the Northeast Quarter of the  
Southwest Quarter (NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Two (2),  
Township one hundred fourteen (114), Range twenty-  
two (22), lying easterly of Jo-Anna Stepka's Hi-  
View Addition to Prior Lake and Jo-Anna Stepka's  
Hi-View Second Addition to Prior Lake and lying  
southerly of an extension of the northerly line  
of the said Jo-Anna Stepka's Hi-View Addition to  
Prior Lake,

have petitioned the Village Council of the Village of Prior Lake,  
Minnesota, to have the above described land which lies outside the  
Village of Prior Lake, Minnesota, annexed to the Village of Prior  
Lake, Minnesota; and

WHEREAS, the Village Council deems it advisable and in the  
public interest that said property be so annexed,

NOW THEREFORE, the Village Council of the Village of Prior  
Lake, Minnesota, does ordain as follows:

SECTION 1.

That the following described property to-wit:

All of Block One Jo-Anna Stepka's Hi-View  
2nd Addition to Prior Lake, and

All that part of the Northeast Quarter of the  
Southwest Quarter (NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section two (2),  
Township one hundred fourteen (114), Range twenty-  
two (22), lying easterly of Jo-Anna Stepka's Hi-  
View Addition to Prior Lake and Jo-Anna Stepka's  
Hi-View Second Addition to Prior Lake and lying  
southerly of an extension of the northerly line of  
the said Jo-Anna Stepka's Hi-View Addition to  
Prior Lake,

which lies outside the corporate limits of the Village of Prior Lake,  
Minnesota, be and the same is hereby annexed to the Village of Prior  
Lake, Minnesota, and said property is hereby declared to be an addition  
to said Village.

Upon the execution date of this Ordinance such property shall become a part of said Village as effectively as if it had been originally a part thereof.

SECTION 2.

This Ordinance shall take effect and be in force from and after its passage and publication and the Village Clerk is hereby directed to cause certified copies of this Ordinance to be recorded and filed in the Office of the Register of Deeds of Scott County, Minnesota, and in the Office of the Secretary of State of the State of Minnesota.
