

CERTIFIED COPY OF ORDINANCE NO. 131 PASSED AND ADOPTED BY THE VILLAGE COUNCIL OF THE VILLAGE OF FARMINGTON ON THE 20TH DAY OF OCTOBER, 1958, DECLARING CERTAIN LAND IN EMPIRE TOWNSHIP ANNEXED TO THE VILLAGE OF FARMINGTON.

ORDINANCE NO. 131

ORDINANCE DECLARING CERTAIN LAND IN
EMPIRE TOWNSHIP ANNEXED TO THE VILLAGE
OF FARMINGTON

The Village Council of the Village of Farmington do ordain as follows:

Section 1.

That all of the owners of all of the land hereinafter described have petitioned the Village Council of the Village of Farmington to have said land included within the Village of Farmington.

Section 2.

That said land does not exceed 200 acres in area, is territory abutting on the Village of Farmington, is not included in any other village or in any city or borough, and is so conditioned as properly to be subjected to the government of the Village of Farmington.

Section 3.

That it is hereby determined that the annexation of said land to the Village of Farmington will be, and is, to the best interests of the Village of Farmington and of the territory affected.

Section 4.

That there is hereby annexed to the Village of Farmington all the land lying and being in the County of Dakota and State of Minnesota, described as follows, to-wit:

All that part of the South Half of the Southeast Quarter ($\frac{1}{4}$ of $\frac{1}{4}$) of Section Thirty (30), Township One Hundred Fourteen (114), Range Nineteen (19), described as follows, to-wit: Commencing at a point 40° North and 20° East of the Northwest corner of Lot Four (4) in Block Two (2) of Sung's Addition; thence North 200 feet; thence East 160 feet; thence South 200 feet; thence West 160 feet to the place of beginning according to the Government Survey thereof.

Section 5.

That this ordinance shall be in full force and effect from and after its passage and publication and the filing of certified copies hereof in the office of the County Auditor of Dakota County and the Secretary of State of the State of Minnesota as required by law.
