

ORDINANCE NO. 4, 1958
AN ORDINANCE EXTENDING
THE CORPORATE LIMITS OF
THE VILLAGE OF PAYNES-
VILLE, STEARNS COUNTY
MINNESOTA TO INCLUDE
CERTAIN UNPLATTED LAND
NOT EXCEEDING 200 ACRES
IN AREA.

WHEREAS, a certain petition dated
June 23, 1958 requesting the annexation
of the territory described below was
presented to the Council on the 15th
day of October 1958;

THE COUNCIL OF THE VILLAGE
OF PAYNESVILLE ORDAINS:

Section 1. Declaration. It is hereby
determined that the territory describ-
ed below abuts upon the Village and
is so conditioned as properly to be
subjected to Village Government.

Section 2. Territory Annexed. The
corporate limits of the Village are
hereby extended to include the ter-
ritory described as follows:

That part of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ in sec-
tion 17, Township 122 North, Range
32 West bounded and described as
follows: Beginning at the intersec-
tion of the south-westerly right-of-
way line of Minnesota Highway No.
55 and the South line of Main Street,
which is also the north line of the
Northwest Quarter (NW $\frac{1}{4}$) of the
Southeast Quarter (SE $\frac{1}{4}$) of said sec-
tion; Thence southeasterly along said
south-westerly right-of-way line for a
distance of 40 feet, more or less, to
the East line of the North-west Quar-
(SE $\frac{1}{4}$) of said section; Thence souther-
ly along said east line a distance of
365 feet, more or less, to the inter-
section of a line which is parallel to
and 415 feet south of the South line
of Main Street; Thence westerly along
said parallel line 420 feet, more or
less, to the east right-of-way line of
Minnesota Highway No. 23; Thence
northerly along said right-of-way line
415 feet to the said south line of Main
Street; Thence easterly along said
south line of Main Street 390 feet,
more or less, to the point of beginning
containing 3.99 acres more or less.

Section 3. Filing. The Village Clerk
is hereby directed to file certified
copies of this ordinance in the office
of the Secretary of State and in the
office of The County Auditor of
Stearns County.

Section 4. Effective date of Annex-
ation. Annexation shall be complete
from and after the date when certified
copies have been filed as directed in
section 3.
