That part of the Northwest Quarter of Section 2, Township 108 North Range 9 West of the Fifth Principal Meridian lying Northeasterly of the above described parcel 1 and southwesterly of the Chicago, Milwaukee, St. Paul and Pacific Railroad right of way.

Parcel One

Commencing at the Northwest corner of the Northeast Quarter, Section 2, Township 108 North, Range 9 West of the Fifth Principal Meridian; Thence East on the Section line a distance of 333.24 feet; thence north 9.05 feet; thence north 41 degrees 23 minutes 19 seconds West 10 feet; thence South 41 degrees 23 min. 19 sec. E. 10 ft.; thence deflect to the left 1 deg. 32 min. 20 sec. curve. Radius 3568.94 ft, delta angle 32 deg. 48 min. for a distance of 12.1 ft to the point of beginning, said point being on the North line of said Section 2; thence continuing on said curve for a distance of 1987.9 ft; thence deflect to the right 90 deg. 00 min. on a bearing South 33 deg. 03 min. 21 sec. W. a distance of 400 ft thence deflect to the right 90 deg. 00 min., thence deflect to the right 1 deg. 23 min. 20 sec. curve, Radius 4068.94 ft. a distance of 2217.24 ft. thence North 208.1 ft. to the point of beginning.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF Minnetonka TO INCLUDE CERTAIN PLATTED LAND (UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA)

Whereas, a certain petition dated October 3, 1958, requesting annexation of the territory described below was duly presented to the council on the 5 day of November, 1958.

The Council of the Village of Minnetonka ordains:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows:

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State and in the office of the county auditor of Wabasha County and the County auditor of Wabasha County.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after date when certified copies of this ordinance have been filed as directed in Section 3.
