ORDINANCE NO. 119

An Ordinance Annexing certain land in the West Half of the East Half of the Northeast Quarter of Section 20, Township 30 North, Range 21 West to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORATY AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by a majority of the owners of the land hereinafter more particularly described, in Washington County, Minnesota, containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and after hearing duly held after thirty days posted notice thereof, and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described by the following boundary lines:

All that part of the West Half of the East Half of the Northeast Quarter ($W\frac{1}{2}$ of $E\frac{1}{2}$ of $NE\frac{1}{4}$) of Section Twenty (20) Township Thirty (30) North, Range Twenty-One (21) West described as follows:

Commencing at the intersection of the center lines of Hallam and Maple Streets in the Village of Mahtomedi; thence East along the center line Maple Street to a point due South of the Southeast corner of Lot Two (2) of East Shore Garden Lots; thence North and along the East lines of Lots Two (2) and One (1) of East Shore Garden Lots to the Northeast Corner of said Lot One (1); thence continuing North in a straight line to the Southerly Shore of Long Lake; thence Northwesterly along said shore of Long Lake to West line of the East Half of Northeast Quarter ($E\frac{1}{2}$ of $NE\frac{1}{4}$) of said Section Twenty (20); thence South along the West line of the East Half of the Northeast Quarter ($E\frac{1}{2}$ of $NE\frac{1}{4}$) to the North line of the Northern Pacific Railway right-of-way; thence Southerly in a straight line to the North end of the center line of said Hallam Street; thence South along the center line of said Hallam Street to the point of beginning:

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and Secretary of State of the State of Minnesota and from and after its publication.
