ORDINANCE NO. 1.7005

An Ordinance Extending the Corporate Limits of the Village of Madelia, Minnesota, to Include Certain Platted Land. THE VILLAGE COUNCIL OF THE VILLAGE OF MADELIA, MINNESOTA ORDAINS:

Section 1. DECLARATION. Petitions having been filed with the village clerk by the owners of the territory described below requesting the annexation of said territory to the Village of Madelia, Minnesota, and requesting the extension of the village boundaries to include the same, which petitions were duly presented to the Village Council on November 10, 1958, it is hereby determined that said territory consists of land which has been platted, abuts upon the village of Madelia and is so conditioned as properly to be subjected to village government.

Section 2. TERRITORY ANNEXED. The corporate limits of the Village of Madelia, Minnesota, are hereby extended to include the territory described as follows:

A. Lots 1, 2, 19 and 20 of Block 2 of Farnsworth's Addition to Madelia.

B. Lot 7, less the South 65 feet thereof of Block 2 of Farnsworth's Addition to the Village of Madelia, Minnesota.

C. Lots 5 and 8 of Block 2 of Farnsworth's Addition to the Village of Madelia, Minnesota.

D. Lots 3, 4, 17, 18, 19 and 20 of Block 1 of Farnsworth's Second Addition to the Village of Madelia, Minnesota, and Lot 2 of Block 1 of Farnsworth's Addition to the Village of Madelia, Minnesota.

E. Lots 5, 6, 7, 11, 12, 13, 14, 15 and 18 of Block 1 of Farnsworth's Second Addition to the Village of Madelia, Minnesota.

F. The South 60 feet of the West one-half of Lot A of the West one-half of the northwest quarter of Section 26, Township 107, Range 30.

Section 3. FILING. The Village clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State and in the office of the County Auditor of Watonwan County, Minnesota.

Section 4. EFFECTIVE DATE OF ANNEXATION. Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3.
