

ORDINANCE NO. 118

AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF CERTAIN TERRITORY TO THE VILLAGE OF
WALKER ON PETITION OF ED WOLD, HUGH HARMER,
ELLEN HARMER AND ALFRED OBERG.

WHEREAS, Ed Wold, Hugh Harmer, Ellen Harmer and Alfred Oberg
have presented to the village council of the Village of Walker, Minnesota,
a petition as follows:

We, the undersigned, being all of the owners of
the west 620 feet of that portion of Government Lot 2,
Section 23, Township 142, Range 31, lying and being south
of Summit Avenue of Commercial Club's Addition to Walker,
including all of the Plat of Harmer's First Addition to
the Village of Walker, and all the unplatted part of said
Lot 2 lying southerly therefrom, said tract being adjacent
to the present corporate limits of Walker and containing
less than 200 acres in area, do hereby petition the village
council to annex the above described tract, pursuant to
Section 412.041, to the Village of Walker.

which said petition is duly acknowledged by said parties; and,

WHEREAS, the said council has by resolution duly passed decided
to grant said petition:

NOW, THEREFORE, the village council of the Village of Walker does
ordain as follows:

Section 1. That the following described land abutting upon the
Village of Walker, to-wit: The west 620 feet of that portion of Government
Lot 2, Section 23, Township 142, Range 31, lying and being south of Summit
Avenue of Commercial Club's Addition to Walker, including all of the Plat
of Harmer's First Addition to the Village of Walker, and all the unplatted
part of said Lot 2 lying southerly therefrom, be and the same is hereby
annexed to, included within, and made a part of the incorporated Village
of Walker.

Section 2. This ordinance shall be in force from and after its
passage and publication and the filing of certified copies thereof in the
office of the County Auditor of Cass County, Minnesota, and in the office
of the Secretary of State of the State of Minnesota.
