NOW, THEREFORE, be it resolved by the Board of County Commissioners of Benton County in regular meeting assembled this 6th day of January, 1959, that:

1. Said petition is hereby accepted and filed with the County Auditor.
2. That an election is hereby directed to be held within the area described in the petition, to-wit: at the Veterans of Foreign War Hall in the Village of Gilman on Saturday, January 29th, 1959 between the hours of 2 o'clock P. M. and 6 o'clock P. M. of said day, during which period the polls shall be open.
3. That notices of said election and a copy of the petition be posted at not less than twenty (20) days before said election date in three (3) public places within the area described in the petition.
4. That there are hereby appointed three (3) electors resident in said area to act as judges of election, namely, Dennis Niedzielski, Robert Soppelt and W. J. Wojciechowski; provided, that should either of said named judges be unable to serve, then, in that case in the order named there are hereby appointed the following to serve as substitute or alternate judges, namely, Frank Knutch and Donald P. Scillicchio.
