ORDINANCE NO. 159
AN ORDINANCE ANNEXING CERTAIN LAND ABUTTING ON
THE CITY OF HOPKINS DETACHED FROM THE VILLAGE
OF EDINA

THE CITY COUNCIL OF THE CITY OF HOPKINS DOES HEREBY OR-
DAIN AS FOLLOWS:

WHEREAS the City Council of the City of Hopkins has received and considered a petition pursuant to M.S.A., Secs. 413.137, which petition is duly and properly signed and executed by all of the owners of the premises hereinafter set forth and described, which petition prays that said premises be detached from the Village of Edina and annexed to and by the City of Hopkins, and

WHEREAS all of said premises abut upon and are contiguous to the City limits of the City of Hopkins, and

WHEREAS the Village Council of the Village of Edina by its Ordinance No. 15-1, has caused all of said premises to be detached from the Village of Edina and has consented to the annexation thereof by the City of Hopkins, and

WHEREAS said petition is in all respects correct and sufficient and in compliance with the provisions of said statute and such detachment from the Village of Edina is hereby found to be for the benefit of the Village of Edina and such annexation of said premises is hereby found to be for the benefit of the City of Hopkins.

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF HOPKINS, MINNESOTA AS FOLLOWS:

Sec. 1. The following described premises and parcels of land, viz: Commencing at the Northwest corner of Section 29, Township 117, Range 21; thence South along the West line of said Section, 74 feet to the Southerly line of the abandoned right of way of the Mpls. and St. Paul Suburban Railway; thence Easterly along the Southerly line of said right of way to its intersection with the West line of Gunnar Johnson's Second Rearrangement, Rolling Green; thence North along the West line of said Rearrangement and its extension to the North line of said Section 29; thence West along said North line to the point of beginning.

That part of the Northwest Quarter of Section 30, Township 117, Range 21, and of Blocks 7 and 8 in West Minneapolis Heights described as follows: Commencing at the Northwest corner of said Section 30; thence East along the North line of said Section to its intersection with the East line of Jefferson Avenue in West Minneapolis Heights extended North; thence south along said East line and its extension to a point in the West line of Lot 26, Block 6 West Minneapolis Heights, distant 30 feet North of the Southwest corner thereof; thence Westerly on a line 30 feet North of and parallel with the South lines of Lots 1 and 26, Block 7, and Lots 1 and 26, Block 8, and the extensions of said lines in West Minneapolis Heights to the West line of said Section 30; thence North along said West line to the point of beginning.

are hereby annexed and declared to be a part of the City of Hopkins, Hennepin County, Minnesota as effectually as if said premises had been originally a part thereof.

Sec. 2. The City Clerk is hereby authorized and directed to file one certified copy of this Ordinance with the County Auditor of Hennepin County, Minnesota and another such certified copy with the Secretary of State of Minnesota.

First read at a regular meeting of the Council of the City of Hopkins on the 2d day of December, 1958, and finally read and adopted at a regular meeting of the Council of said City held on the 16th day of December, 1958.
