CHAPTER 56

AN ORDINANCE ANNEXING CERTAIN
PLATTED LAND IN NORTH HALF OF
NORTHEAST QUARTER OF SECTION 3,
TOWNSHIP 107, RANGE 34, COTTONWOOD
COUNTY, MINNESOTA, TO THE VILLAGE
OF COMFREY.

THE VILLAGE OF COMFREY DOES ORDAIN:

SECTION 1. That the petition of all the owners of the following described platted land, lying and being adjacent to and abutting on the corporate limits of the Village of Comfrey, and not being included in any other village, to-wit:

Steinmetz Addition to Comfrey in the North Half (NW $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Number Three (3), Township Number One Hundred Seven (107), Range Number Thirty-four (34), in the County of Cottonwood, State of Minnesota, consisting of Lots Numbers One (1) through Fourteen (14), but excepting therefrom Lots Numbers Eleven (11), Twelve (12), Thirteen (13), and Fourteen (14) thereof,

to have such land included within the Village of Comfrey, filed with the Village Clerk of this Village on October 1st, 1958, is hereby approved.

SECTION 2. That the annexation of said land to the Village of Comfrey will be to the best interests of the Village and of the territory affected.

SECTION 3. That the said land be and the same hereby is annexed to the Village of Comfrey, and included within the corporate limits of the Village of Comfrey.

SECTION 4. This ordinance shall have effect and be in force from and after its passage, approval and publication.


