ORDINANCE 13

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WOLF LAKE TO INCLUDE CERTAIN PLATTED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS, a certain petition dated December 18, 1958, requesting annexation of the territory described below was duly presented to the council on the 13 day of January 1959.

The Council of the Village of Wolf Lake ordains:
Section 1. Declaration. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows: "Beginning at the Southwest Quarter (sw ¼ sw ¼) of Section Thirty-four (34). Township One Hundred Thirty-in ne (139) North. Range Thirty-seven (37) West of the Fifth (5th) Principal Meridian in Becker County, Minnesota, and running in a Northerly direction one thousand eighty-nine (1089) feet; thence running four hundred twenty-two (422) feet in the Easterly direction; thence running Southerly one thousand eighty-nine (1089) feet; thence running four hundred twenty-two (422) feet to the point of beginning and there terminating."
