

RESOLUTION DECLARING THE RELINQUISHMENT OF THE OLD ORGANIZATION  
OF THE VILLAGE OF CENTER CITY, CHISAGO COUNTY, MINNESOTA,  
AND RE-INCORPORATION UNDER CHAPTER NINE (9) OF THE  
REVISED LAWS OF 1905 AS AMENDED.

WHEREAS, the Village of Center City, Chisago County, Minnesota,  
was organized and now exists and is governed pursuant to and by  
Chapter 145, General Laws of Minnesota of 1885 and amendments  
thereto;

AND WHEREAS, the Village Council of said village did by  
resolution dated the 8<sup>th</sup> day of February 1915, order  
that a special election of the electors of said village of  
Center City be held at the village hall in the said village of  
Center City, Chisago County, Minnesota, on Tuesday the 9th day of  
March 1915, between the hours of nine o'clock A.M. and five  
o'clock P.M., to vote upon the question of relinquishing the old  
organization of said village, and to be re-incorporated and to be  
governed by Chapter 9 of the Revised Laws of 1905 as amended;

AND WHEREAS, at the special election so held by the electors of  
the said village on the 9th day of March 1915, there were cast  
Forty three (43) votes of which there were cast for  
re-incorporation, Forty (40) votes and against re-incorporation  
Three (3) votes, being a majority of Thirty Seven (37) votes  
in favor of re-incorporation.

NOW, THEREFORE, it is hereby resolved that the <sup>said</sup> village of  
Center City, does hereby relinquish the old organization under  
which it now exists, being Chapter 145, General Laws of Minnesota  
of 1885 and amendments thereto; and that it does hereby re-incorpor-  
ate and re-organize as a village pursuant to the provisions of  
Chapter 9 of the Revised Laws of 1905 as amended, and that  
hereafter the said village of Center City shall be governed by  
the General Laws of the State of Minnesota as set forth in

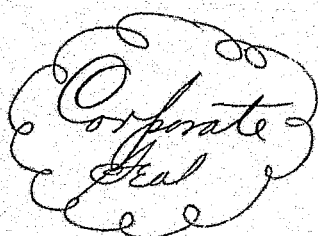
NOW, THEREFORE, it is hereby resolved that the <sup>said</sup> village of
