NOW, THEREFORE, it is hereby resolved that the village of Center City, does hereby relinquish the old organization under which it now exists, being Chapter 145, General Laws of Minnesota of 1885 and amendments thereto; and that it does hereby re-incorporate and re-organize as a village pursuant to the provisions of Chapter 9 of the Revised Laws of 1905 as a mended, and that hereafter the said village of Center City shall be governed by the General Laws of the State of Minnesota as set forth in Chapter 9 of the Revised Laws of 1905 and amendments thereto.

AND WHEREAS, the Village Council of said village did by resolution dated the Standay of February 1915, order that a special election of the electors of said village of Center City be held at the village hall in the said village of Center City. NOW, THEREFORE, it is hereby resolved that the village of Center City, does hereby relinquish the old organization under which it now exists, being Chapter 145, General Laws of Minnesota of 1385 and amendments thereto; and that it does hereby re-incorporate and re-organize as a village pursuant to the provisions of Chapter 9 of the Revised Laws of 1905 as a mondod, and that hereafter the said village of Center City shall be governed by the General Laws of the State of Minnesota as set forth in Chapter 9 of the Revised Laws of 1905 and amendments thereto.

Be it further resolved, that all ordinances of the said village of Center City now existing and not in conflict with the provisions of the new charter shall be and hereafter remain in effect until modified, amended or repealed.
