AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SAUK RAPIDS AND INCORPORATE ADDITIONAL TERRITORY THEREIN

THE VILLAGE COUNCIL OF THE VILLAGE OF SAUK RAPIDS DOES ORDAIN:

Section 15:04. Village Boundaries Extended. Pursuant to a petition duly signed by all of the owners of the land described as follows:

That part of the South one-half of the Southwest one-quarter of the Southvest one-quarter (St SWt SWt) of Section Fourteen (14), Township Thirty-six (36) North, Renge Thirty-one (31) West, to-wit: Beginning at a point on the East line of a Tourship Road as now constructed and traveled Thirty-three (33) feet due East of the Northwest corner of seld South onehalf of the Southwest one-quarter of the Southwest one-quarter ($S_{\rm P}^{\perp}$ SN¹/₂ SN¹/₃ SN¹/₃) of said Section Fourteen (14), Township 36, Range 31; thence due East along the North line of said South one-half of the Southwest one-quarter of the Southwest one-quarter (St SW1 SW1) for One Hundred Soventy (170) feet; thence due South and parallel with the West line of said South onehalf of the Southwest one-quarter of the Southwest one-quarter (St SHt SHt) Three Hundred Forty-nine and seven-tenths (349.7) feet to the Northeast corner of Lerson's Second Addition; thence West along the North line of said Larson's Second Addition One Hundred Seventy (170) feet to an intersection with the said East line of said Township Road; thence North along said East line of said Township Road for Three Hundred Fifty and five-tenths (350.5) feet to the point of beginning and there terminating, said tract containing One and thirty-seven hundredths (1.37) acres, more or less, and platted as Larson's Third Addition.
