





ORDINANCE NO. 1.7006

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MADOLIA, MINNESOTA TO INCLUDE CERTAIN PLATTED LANDS

THE VILLAGE COUNCIL OF THE VILLAGE OF MADOLIA ORDAINS:

Section 1. DECLARATION.

A resolution having been duly adopted on December 8, 1958, by the Village Council of the Village of Madolia, Minnesota, declaring the intention of the Village Council to annex the lands hereinafter described, which lands are completely surrounded on all sides by lands already included within the corporate limits of the Village of Madolia, and notice of hearing on said proposed annexation having been duly served, posted and published as provided by law, a hearing thereon was held on January 12, 1959, at 8:00 P.M. in the Village hall of the Village of Madolia, Minnesota. It is hereby determined that the lands described herein are not presently included within the incorporated limits of the Village of Madolia, Minnesota, are completely surrounded on all sides by lands already included within the corporate limits of the village, and are so conditioned as properly to be subjected to village government.

Section 2. TERRITORY ANNEXED.

The corporate limits of the Village of Madolia, Minnesota, are hereby extended to include the territory described as follows:

- Tract No. 1 - Lot 1 of Block 1 of Farnsworth's Addition to Madolia, Minnesota.
- Tract No. 2 - Lots 3, 4, 17 and 18 of Block 2 of Farnsworth's Addition to the Village of Madolia, Minnesota.
- Tract No. 3 - Lots 15 and 16 of Block 2 of Farnsworth's Addition to the Village of Madolia, Minnesota.

Section 3. FILING.

The village clerk is hereby directed to file certified copies of this Ordinance in the office of the Secretary of State and in the office of the County Auditor of Watonwan County, Minnesota.

Section 4. - EFFECTIVE DATE OF ANNEXATION.

Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3.
