ORDINANCE NO. 121

An Ordinance Annexing Part of Former Street
Jar Right-of-way Lying Between Juniper and
Iris Streets, to the Village of Mahtomedi.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by the sole owner of the land hereinafter more particularly described in Washington County, Minnesota, containing less than two hundred acres, surrounded by land of the Village of Mahtomedi, requesting the annexation of said land to said village, said petition having been duly filed with the Clerk of said village; and it appearing that such annexation will be to the best interests of the village and of the territory affected, the village boundaries of the Village of Mahtomedi are hereby extended to include the following described land, in Washington County, Minnesota, to-wit:

That part of Government Lot Four (4), Section Twenty (20), Township Thirty (30), Range Twenty-one (21),

beginning at a point where the westerly right-of-way line of Minneapolis and St. Paul Suburban Railway Company intersects with northerly line of former Lot Ten (10) Block Eleven (11), Town of Wilson now vacated; thence Southwesterly along aforesaid right-of-way line to its intersection with center line of Iris Street, formerly known as Woodland Avenue; thence Easterly on center line of Iris Street, formerly known as Woodland Avenue to its intersection with Easterly line of Minneapolis and St. Paul Suburban Railway Company right-of-way; thence Northeasterly along aforesaid right-of-way line to its intersection with Northerly line of former Lot Ten (10) Block Eleven (11), Town of Wilson now vacated; thence westerly on northerly line of aforesaid Lot Ten (10) or northerly line produced to point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as of the same had originally been a part of said village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and Secretary of State of the State of Minnesota and from and after its publication.
