RESOLUTION NO. 260

RESOLUTION REQUESTING THAT AN ELECTION BE HELD ON THE QUESTION OF
ANNEXING CERTAIN TERRITORIES TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, a certain petition dated the 24th day of March, 1959, requesting that an election be held on the question of annexing certain territory described therein to the City of White Bear Lake, Minnesota, was duly presented to this Council on the 24th day of March, 1959.

WHEREAS, said petition is in proper form and it appears therefrom that the same was signed by the required number of legal voters and that the territory therein described contains 2365 persons and is within one and one half miles of this City Limit; and,

WHEREAS, the territory proposed to be annexed is properly to be subjected to City Government; and,

WHEREAS, this Council finds that annexation would be to the best interests of the City and of the territory to be annexed,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of White Bear Lake, Ramsey County, Minnesota:

That an election is hereby called and directed to be held on the 4th day of April, 1959, at the Mansell Piper garage, 3714 White Bear Avenue, at which election all qualified voters residing within the territory described in said petition may vote for or against the annexation of said territory to the City of White Bear Lake; and the polls at said election shall be open from 7:00 A.M. o'clock until 8:00 P.M. o'clock of said day.

1. Mrs. Evelyn Pederson, Eleanor Elinger and Betty Peterson, all residents within said territory, are hereby appointed to be Judges of said election, and the Judges of said election shall conduct the election so far as practicable in accordance with the laws regulating the election of City Officers.

2. That the City Clerk shall cause notice of said election to be given in the manner prescribed by law.

The foregoing Resolution was offered by Councilman Teuber and on his motion, supported by Councilman Quirk, was declared carried on the following vote:

TO THE CITY OF WHITE BEAR LAKE:

We, the undersigned, residents and legal voters of the territory hereinafter described, hereby petition your council and request that you order an election on the question of annexing the territory hereinafter described, to the City of White Bear Lake, Minnesota.

We further petition that your council fix a time and place where said election shall be held.

I

That all of your petitioners are legal voters and residents of the territory hereinafter described.

II

That none of the territory hereinafter described is now a part of any incorporated city or village.

III

That the territory, which it is proposed to annex, contains a resident population of more than 75 persons and no part of the land is more than one and one-half miles from the city limits of the City of White Bear Lake.
