

IN RE: PETITION OF J. D. SABLE AND NORTHERN
NATURAL GAS COMPANY, OWNERS, TO DETACH CERTAIN
LANDS FROM THE VILLAGE OF ILLION

ORDER

At a regular meeting of the village council of the Village of Illion, duly
held upon due notice and call thereof, on April 6th, 1959 at 8:00 o'clock, P. M.,
at the fire hall at which the following members were present:
John Westerbur, Mayor Raymond Hein, Trustee Mrs. Marie Campion, Clerk
Hal Parker, Trustee Guy Hazelton, Trustee
and the following members were absent: None

the petition of J. D. Sable and Northern Natural Gas Company to Detach certain
lands within the village limits owned by them from the Village of Illion was
presented for consideration. Upon the facts stated in said petition and upon
all the records and files and evidence pertinent thereto, the village council
finds as follows:

1. That said petitioners are the owners of the tract of land hereinafter
described.
2. That said tract of land is unplatted and is within the corporate limits
of the Village of Illion, but lies adjacent to the village boundaries and is
unimproved and is occupied and used solely for agricultural purposes.
3. That the detachment of said tract of land from the Village of Illion
would not unreasonably affect the symmetry of the settled portions thereof
and would not injuriously affect the reasonable exercise of the powers and
functions of the village and would not reduce the number of inhabitants of the
village below the minimum number required by law and would be for the best
interests of the territory affected.

IT IS THEREFORE ORDERED, That the following described tract or parcel of land
of the petitioners, viz:

That part of the NE¹/₄-16-105-46, Pipestone County, Minnesota, lying and
being westerly of the right of way of the Great Northern Railway Company,
and northerly of the south boundary of the corporate limits of the Village
of Illion,

excepting however easements thereon for public highways, or streets,
be DETACHED from the Village of Illion, and that an ordinance be enacted to
effectuate such detachment thereof.

excepting however easements thereon for public highways or streets, is hereby detached from the Village of Ihlen, Minnesota.

Section II. That this ordinance shall be in full force and effect after its passage and publication as by law provided, and certified copies thereof duly filed with the Auditor of Pipestone County and with the Secretary of State of the State of Minnesota.
