

I, LEONARD A. JOHNSON, City Clerk of the City of Minneapolis, in the County of Hennepin and State of Minnesota, do hereby certify that proposed Amendment No. 17 to the City Charter of the City of Minneapolis, of which the attached is a true and correct copy, was submitted to the electorate at a Special Election held at the same time as the General Municipal Election on Tuesday, June 9, 1959; that notice of said Special Election and the proposed Amendment No. 17 to the City Charter were duly published, all pursuant to the Statutes of the State of Minnesota and the action of the City Council of the City of Minneapolis on April 24, 1959; that at the said Special Election held as above stated, there were 104,327 votes cast on the question; that the number of votes cast in favor of the said proposed amendment was 61,010; that the number of votes cast against the said proposed amendment was 43,317; that the number of votes necessary for the adoption of said proposed amendment was 55 per cent, or 57,380; that said proposed Amendment No. 17 was duly adopted by the qualified voters of the City of Minneapolis and therefore becomes Amendment No. 16 to the City Charter of the City of Minneapolis.

AMENDMENT NO. 17 (City Charter Amendment No. 16)

The City Charter of the City of Minneapolis is hereby amended by amending the first subdivision of Section 5 of Chapter 4 by striking out all of said subdivision after the first three paragraphs, and inserting in lieu thereof the following:

"Provided further, that except as provided in this subdivision, no license shall be granted to any person or persons to vend, deal in, or dispose of any spiritous, vinous, fermented or malt liquors (except to regularly licensed druggists, to sell for medicinal, chemical or mechanical purposes, not to be used or drunk upon the premises), outside of the following territory in said city, to-wit:

"Commencing at the intersection of the east bank of the Mississippi River and Second Avenue Southeast; thence along the center line of Second Avenue Southeast to the intersection of Ninth Street Southeast; thence along the center line of said Ninth Street and along the center line of Division Street, easterly to the center line and intersection of Tyler Street; thence north along the center line of said Tyler Street to the center line of Spring Street; thence west to the intersection of Washington Street with Spring Street; thence across said Washington Street to the intersection of Fifth Street and Sixth Avenue Northeast; thence southwest along the center line

of said Sixth Avenue to the intersection of Fourth Street Northeast; thence northwest along the center line of Fourth Street Northeast to the center line of Broadway Street; thence east along the center line of Broadway Street to the intersection of the center line of Fourth Street Northeast, formerly Four-and-one-half Street Northeast; thence north along the center line of said Fourth Street Northeast to the north limit of the City of Minneapolis, as the same existed February 28, 1887; thence west on the said north limit of the City of Minneapolis to the east bank of the Mississippi River; thence along the east bank of the Mississippi River; thence along the east bank of the Mississippi River to the place of beginning; also, all that part of Nicollet Island embraced within the distance of one hundred and fifty feet on either side of East Hennepin Avenue across said Island.

"Commencing at the intersection of the west bank of the Mississippi River and Twenty-first Avenue North and running thence west along the center line of said Twenty-first Avenue North to the intersection of Fourth Street North; thence south along the center line of said Fourth Street North to the denter of Fourteenth Avenue North; thence west along the center line of said Fourteenth Avenue North to the center of Lyndale Avenue; thence south along the center line of said Lyndale Avenue to the center of Hennepin Avenue; thence south along Hennepin Avenue to the center line of Douglas Avenue; thence west along the center line of Douglas Avenue to the center line of Bryant Avenue South; thence south along the center line of Bryant Avenue South to the center line of Lincoln Avenue; thence west along the center line of Lincoln Avenue to the center line of Colfax Avenue South; thence south along the center line of Colfax Avenue South to the center line of West Franklin Avenue; thence west along the center line of West Franklin Avenue to the center line of Dupont Avenue South; thence south along the center line of Dupont Avenue South to the center line of West 22nd Street; thence east along the center line of West 22nd Street and East 22nd Street to the center line of Elliot Avenue; thence north along the center line of Elliot Avenue to the center line of East 21st Street; thence east along the center line of East 21st Street to the center line of 15th Avenue South; thence south along the center line of 15th Avenue South to the center line of East 22nd Street; thence east along the center line of East 22nd Street to the center line of 31st Avenue South; thence north along the center line of 31st Avenue South to the center line of East Franklin Avenue; thence east along the center line of East Franklin Avenue to the west bank of the Mississippi River; thence northerly along the west bank of the Mississippi River to the center line of 19th Avenue South; thence along the west bank of the Mississippi River to the place of beginning.

"Licenses for the sale of intoxicating liquor, off-sale or on-sale, may be issued outside the above described territory upon the following conditions:

- "(a) A liquor license may be issued for a location which at the time of issuance is being used for, or the latest use of which was for, the sale of intoxicating liquor.
- "(b) Except as provided in (a), a liquor license may be issued only when approved by a referendum as follows:
 - "(1) The voting area in which the referendum shall be held shall include the ward in which the location is situated and any precincts or groups of precincts which fall wholly or partially within the radius of 1500 feet measured in a straight line from the front door of the proposed location.
 - "(2) Such referendum shall be held at either the next following primary or general municipal or state election.
 - "(3) The application for such license shall be submitted to the City Council and when the City Council shall determine that the location is acceptable, the referendum shall be set. If a majority of those voting at the election in the ward shall vote in favor of issuance of the license for the proposed location, and in addition, if a majority of those voting in the group of precincts which fall wholly or partially within a radius of 1500 feet measured in a straight line from the front door of the proposed location shall vote in favor of issuance of the license, the City Council may issue the license.

"No license as provided herein shall be issued except in such areas of the city as are zoned for commercial or industrial uses.

"Except as herein provided, all such on-sale and off-sale liquor establishments shall continue to be subject to the pertinent statutes of the State of Minnesota and the city ordinances of the City of Minneapolis."
