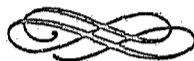

## ORDINANCE No. 2, 1959

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF PAYNESVILLE, STEARNS COUNTY, MINNESOTA TO INCLUDE CERTAIN UNPLATED LANDS NOT EXCEEDING 200 acres in AREA.

WHEREAS, a certain petition dated March 3, 1959 requesting the annexation of the territory described below was presented to the Council on the 20th day of March 1959:

THE COUNCIL OF THE VILLAGE OF PAYNESVILLE ORDAINS:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 2. Territory Annexed. The corporate limits of the Village are hereby extended to include the territory described as follows:

All that part of the Southeast One Quarter of the Southwest One Quarter (SE $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section Sixteen (16), Township One Hundred Twenty-two (122) North, Range Thirty-two (32) West, lying North of the North 75 foot Right of Way line of Trunk Highway No. 55 and West of the West 33 foot Right of Way line of Trunk Highway No. 4 and exclusive of other Trunk Highway and Public Road Right of Ways.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State and in the office of the County Auditor of Stearns County.

Section 4. Effective date of Annexation. Annexation shall be complete from and after the date when certified copies have been filed as directed in Section 3.
