I am returning herewith the two certified copies of Ordinances No. 126 and 127 of the Village of Mahtomedi annexing certain land to said Village. The annexation of the lands described in said ordinances was done pursuant to Chapter 636, laws 1959 under subdivision 7 of section 3 of said law, which provides that any land entirely surrounded by village land (which is the case in ordinance No. 127) and unplatted or platted land less than 200 acres in which the petition is signed by all of the owners (which is the case in ordinance No. 126) then the Village Council may annex such land without going through the Municipal Commission on Annexation. Those jurisdictional facts are recited in each of the ordinances.

This subdivision further provides as follows:

"Any annexation provided for in this subdivision shall be deemed final upon filing a copy of the ordinance with the corression, the county auditor, and the secretary of state."
